Every individual in golf should at all times show respect and understanding for all members' rights, safety and welfare and conduct themselves in a way that reflects the principles of **Carrickmines Golf Club** and the guidelines contained in our Code of Ethics for Juniors.

A very high priority of **Carrickmines Golf Club** is the welfare of juniors and we are committed to providing an environment that will allow participants to perform to the best of their ability, free from neglect, emotional, physical and sexual abuse, bullying and intimidation. Junior coordinators within our club will undergo the necessary Garda Vetting checks and complete appropriate training as required by legislation and best practice.

**Carrickmines Golf Club's** written risk assessment document indicates the areas of potential risk of harm, the likelihood of risk occurring and covers the required policy, guidance and procedures required to alleviate these risks.

In addition to our **risk assessment document**, there are further procedures that support our intention to safeguard children while they are availing of our activities. **Carrickmines Golf Club** has the following procedures in place as part of our Safeguarding Policies and Code of Ethics:
